*ELIGIBILITY

Any person of full age (18 years or over) shall be eligible to hold the office of Procureur of the Poor provided that:

- (a) he is ordinarily resident in this Island on the date of his nomination and he has been ordinarily resident in this Island
 - (i) for a period of two years immediately before that date, or
 - (ii) for a period or periods of at least five years in the aggregate at any time before that date;
- (b) he shall be ordinarily resident in the Parish at the date of his nomination;
- (c) he has not at any time during the five years immediately preceding the date of his election have been sentenced for an offence by a court in the United Kingdom, any of the Channel Islands or the Isle of Man, to imprisonment for a period of six months or more (whether suspended or not) without the option of a fine, unless that sentence was quashed or reduced to less than six months on appeal.
- (d) They are inscribed on the Electoral Roll

Every Procureur of the Poor elected otherwise than for the completion of the unexpired term of a Procureur of the Poor vacating office on death or removal from the parish or whose discharge on account of illness or other circumstances may have been granted by the Ordinary Court, shall remain in office during the two calendar years which shall expire after the commencement of his term of office.

Every Procureur of the Poor elected in the case of a vacancy on account of death, removal from the parish, or discharge granted by the Ordinary Court shall remain in office for the unexpired portion of the term of office of his predecessor.
