***ELIGIBILITY**

Any person of full age (18 years or over) shall be eligible to hold the office of Douzenier provided that:

- (a) They are ordinarily resident in this Island on the date of their nomination and they have been ordinarily resident in this Island
 - (i) for a period of two years immediately before that date, or
 - (ii) for a period or periods of at least five years in the aggregate at any time before that date;
- (b) They shall be ordinarily resident in the Parish at the date of their nomination;
- (c) They are inscribed on the Electoral Roll
- (d) They have not at any time during the five years immediately preceding the date of this election have been sentenced for an offence by a court in the United Kingdom, any of the Channel Islands or the Isle of Man, to imprisonment for a period of six months or more (whether suspended or not) without the option of a fine, unless that sentence was quashed or reduced to less than six months on appeal.

Note: In the event of a contested election the Parish may vote on the night of Wednesday 8 December 2021 to defer the election to a Parish wide vote, which will take place two weeks after the meeting.
